Notes to the Application

1. Under normal circumstances, your service will be activated within 8 – 10 working days. However, subject to telephone line condition or location, it may take about one month or longer for the service to be activated.
2. Note that the required Customer Premise Equipment for ADSL service is an ADSL router-modem with ethernet interface. Other Customer Premise Equipment types are not supported directly by iWorldAccess. Please check with your respective system integrator.
3. IworldAccess ADSL service is not applicable for PABX (Private Automatic Branch Exchange), hunting line, ISDN (Integrated Services Digital Network), DID (Direct Inward Dialing), key telephone system, Auxiliary line and SingTel Faxmail Service.
4. Please include a copy of your **Certificate of Incorporation / Business Registration Certificate** with this application.

Specific Terms and Conditions

1. IworldAccess services are available to companies who fulfill the following requirements:
 - BRN number
 - Existing company registered telephone line (applies to ADSL service only)
 - One telephone line per CPE (applies ADSL service only)
2. If the telephone is not registered under the company's name, the applicant must obtain approval from the registered telephone subscriber for use of Iworld Access's ADSL service
3. There is a minimum subscription period of 12 months for Iworld Access ADSL service (or such other period as may be specified by Iworld Access). This minimum subscription period is imposed by the telephone line provider. Iworld Access has to pay the telephone line provider for the entire minimum subscription period even if the ADSL service is terminated before the end of the period. Iworld Access suffers a loss when this happens, and for most ISPs this loss is borne by good subscribers who honour the minimum subscription period, in the form of higher prices. Iworld Access feels strongly that this is unfair. At Iworld Access, our customers enjoy the lowest prices. Good customers do not subsidize errant customers. At Iworld Access, customers are required to sign the 12-month minimum subscription period contract, and pay the subscription fees for the 7th to 12th month upfront. This allows Iworld Access to keep errant customers at bay, and give our customers the lowest price in the market. The pre-pay 7th-12th month subscription fee is not a deposit or a penalty, but an advance subscription fee. You will not be billed again on the 7th – 12th month.
4. Use of Iworld Access's services is subject to its most current Acceptable Use Policies. These policies among other things require the customer to comply with all applicable laws (and shall not contravene any applicable law) of the Republic of Singapore relating to the Service including without limitation the Broadcasting and Television Act, Common Gaming Houses Act, Computer Misuse Act, Copyright Act, Films Act, Indecent Advertisements Act, Maintenance of Religious Harmony Act, Official Secrets Act, Penal Code, Public Entertainment Act, Telecommunications Act (including any regulation made pursuant thereto and any terms and conditions of any license granted to Iworld Access by IDA) and the Undesirable Publications Act, as well as any policies, directives and guidelines set by IDA and the Singapore Broadcasting Authority. These policies also cover NetAbuse which include (but not limited to) Unsolicited Bulk Email, Unsolicited Commercial Email, Mail Bombing, Denial of Service Attacks etc ...
5. It is understood that IworldAccess services are provided via multiple public and private facilities. Iworld Access shall not be responsible for any failure in its Services arising from faults caused by customer's equipment, applications, interconnected equipment, networks, systems or gateways and/or acts of omissions of the customer, IworldAccess scheduled maintenance or the acts or omissions of local exchange carrier or failure of third party services.
6. It is also understood that while IworldAccess endeavors to provide the services to the best of its efforts, IworldAccess shall not be liable for any cost, claim, liability, expense, demand or damages whatsoever (including any loss of profits, lost savings or incidental or consequential damages) arising out of customer's use of or inability to use such services.
7. Provision of Iworld Access's services are further subject to the company's General Terms and Conditions, and prevailing prices and rates as publicized from time to time.
8. All fees and charges are payable by the Due Date printed in the bill. Interest at 12% per annum is levied on a daily basis on outstanding amounts after the Due Date.
